- <sup>1</sup> RSVP funding levels reflect the actual amount awarded to each RSVP grantee in FY 2011. The FY 2011 budget reduction was implemented by either extending or compressing the grant period, with some grants receiving a 9-month budget period and others receiving a 15-month budget period.
- <sup>2</sup> This figure represents the number of awarded positions available to be filled in the 2011 - 2012 program year. For AmeriCorps VISTA, this represents the actual number of AmeriCorps members in active service.
- <sup>3</sup> This figure represents the maximum potential value of Segal AmeriCorps Education Awards that can be earned by AmeriCorps members serving in Kansas. The award can be used in any state to pay for college, graduate school, vocational training, or to pay back student loans. The education award total is included in total CNCS funding.
- <sup>4</sup> AmeriCorps National figures may include national programs headquartered in the state and/or operating sites of national programs that are headquartered in other states. Some national organizations do not report operating site data, or it wasn't available at time of publishing, so figures may not reflect current conditions.
- <sup>5</sup> Kansas is served by the AmeriCorps NCCC campus located in Denver, Colorado. In the past year, AmeriCorps NCCC teams have served on projects in Greensburg.
- <sup>6</sup> Fiscal Year 2011 and 2012 funding was eliminated for Learn and Serve America but some programs are operating funded by previously approved multi\_year grants.
- <sup>7</sup> Funding levels reflect Fiscal Year 2011 appropriations. Funding for this account was reduced in Fiscal Year 2012.
