### FORECAST OF FUNDING OPPORTUNITIES

#### COMPETITIVE GRANT PROGRAMS FOR FISCAL YEAR (FY) 2012

---

This document presents a forecast of all grant competitions under which the Corporation for National and Community Service (CNCS) expects to invite applications for new awards, and provides actual (or estimated) deadline dates for the submission of applications under each competition. The forecast is organized chronologically, according to the Notices of Funding Opportunity (*Notice*) that have already been announced, or that CNCS plans to announce at a later date.

The competitions listed are based on CNCS' best estimates at this time. CNCS is publishing this document in order to provide potential applicants with information for planning purposes. Potential applicants should note, however, that CNCS may cancel competitions listed as well as announce new competitions not listed in this document.

The presence of a CFDA number for a particular announcement in the chart indicates that the dates are actual and CNCS has already published a *Notice* for those grant competitions. For competitions in which the CFDA number is not indicated, all dates are estimates and CNCS has not yet published the *Notice*. Below is a description of the information provided in the CNCS Forecast for Funding Opportunity FY2012 charts:

**CFDA Number and *Notice* Name.** Column one indicates the Catalog of Federal Domestic Assistance (CFDA) number and the title of the Funding Opportunity.

***Notice* Publication.** Column two lists the actual or estimated date for publication of the *Notice* for a given Funding Opportunity.

**Link to *Notice*.** Column three provides links to currently published *Notice* for a given Funding Opportunity.

**Application Deadline.** Column four indicates the actual or estimated deadline for submitting applications to a given Funding Opportunity.

**Grant Announcements.** Column five indicates the actual or estimated deadline for the announcement of the applications selected for funding.

**Contact Information.** Column six lists e-mail address and telephone numbers for obtaining further information about the programs listed. This information is also included in the actual *Notice* for each competition. The TTY number is 202-606-3472.
