



AmeriCorps State and National End-of-Year Grantee Progress Report Instructions

How will CNCS use the information reported?

The AmeriCorps Grantee Progress Report (GPR) provides information for CNCS staff to monitor grantee progress and to respond to requests from Congress and other stakeholders. Some information provided in your Grantee Progress Report may be used by CNCS's Office of Public Affairs to promote service. Program staff will use the information you provide to identify trends and issues that may lead to changes in policies and procedures, allocation of training and technical assistance, or opportunities for peer learning.

What are the components of the GPR?

The AmeriCorps Grantee Progress Report consists of four sections: Demographic Information, Performance Indicators, Performance Measures, and Narratives.

Please complete the report using eGrants (<http://www.nationalservice.gov/egrants/>), the Corporation's integrated, secure, web-based system for applications, and follow these instructions.

When is the GPR due?

The GPR is due on October 31, 2018.

If you cannot meet the submission deadline for the progress report, you must request an extension from your Program Officer. Requests for extensions may be granted when:

1. The report cannot be finished in a timely manner for reasons legitimately beyond the control of the grantee, and
2. CNCS receives a request explaining the need for an extension before the due date of the report.

Selecting the Right GPR

After logging into eGrants, click the "Progress Report" link in the lower right corner of the screen.

You will see a list of possible progress reports for each of your existing grants. Find the grant number that includes the 2017-2018 program year, and expand the list by clicking on the orange arrow key to the right of the grant number.

Find the progress report with the 10/31/2018 due date labeled "Progress Report Annual," and click on the "edit" link. You will be taken to the main progress report screen.

Reporting Period

The reporting period is from the beginning of your 2017-2018 grant year through the end of the grant year or September 30, 2018, whichever is sooner. Note that this progress report covers the specified reporting period only and is cumulative for the reporting period, meaning it includes data reported in the mid-year GPR. Even if the reporting period listed in eGrants shows just the time period since the mid-year report, the report should include the information for the full reporting period, not just for the period since the mid-year report. The report is not cumulative for the entire three-year grant period and should not include data already reported in past end-of-year GPRs.

If you have demographic or performance measurement data from the previous year of your current three-year grant cycle that were not included in the prior end-of-year GPR (i.e., noted as "ongoing" on prior report due to continuing program activities), please include these data in the "actuals" fields of the current GPR. Provide a note of explanation as described on p. 8 of these instructions clearly explaining which data correspond to which program year. Do this even if you already included the prior-year data in the mid-year GPR.

Commissions will complete one progress report for each of their AmeriCorps State and National prime grants (competitive cost reimbursement, competitive fixed amount, competitive EAP, School Turnaround AmeriCorps, formula cost reimbursement, formula fixed/EAP, etc.) providing information as follows:

- In each prime grant, the grantee reports on performance measurement data for that prime grant.
- State commissions report on demographics and narratives for all grants except School Turnaround AmeriCorps in the formula cost-reimbursement prime.
- Performance measure data, demographic data, and narratives for School Turnaround AmeriCorps subgrantees will be reported in the School Turnaround AmeriCorps GPR. Failure to provide all School Turnaround AmeriCorps data and narratives in the School Turnaround AmeriCorps GPR will result in having the GPRs returned for correction.

Data submitted in the Progress Report must be valid (i.e., the data collected and reported must accurately align with the performance measure instructions, approved program design, and grant application) and verifiable (i.e., the grantee must be able to demonstrate the data are accurate). Source documentation that supports the reported results must be maintained as grant records.

**Individual volunteers may not be counted in both the episodic and ongoing volunteer categories; the sum of the volunteers reported in these two categories must represent an unduplicated count. If you are unsure whether a volunteer is episodic or ongoing, report it the "episodic" category.*

The following indicators are NOT required; however, if your program collects data on any of these indicators, you are required to include it in the progress report:

- Number of local disasters to which AmeriCorps members have responded

- Number of active duty military members served

Note: Indicators labeled “School Turnaround” should only be completed by School Turnaround grantees on the School Turnaround AmeriCorps GPR. All other programs must enter zero in these fields. Please refer to the School Turnaround AmeriCorps GPR Instructions for further guidance.

To complete the Demographics tab, refer to the demographic definitions in the GPR Supplemental Guidance. Enter the appropriate numerical data in each category for which you have collected information. If you do not collect data on an indicator, enter a zero (0) in that field. The progress report cannot be submitted until there is a numerical value, including zero, entered in every field on this tab.

If you wish to provide an explanation about the data you have entered on this tab, clicking on the “Grantee Narrative” bar will open a text box for this purpose. This is not required. *(Please note: there is a 2,000-character limit on the Grantee Narrative text box; any text entered above the character limit will not be saved.)*

Commissions should enter demographic data for all competitive and formula subgrantees except School Turnaround AmeriCorps subgrantees in the formula cost reimbursement GPR only. Demographic data reported should not be duplicated in any other CNCS grantee progress reports including but not limited to Commission Support Grant, Volunteer Generation Fund, Commission Investment Fund, VISTA or Senior Corps progress reports.

If you have demographic data from the previous year or previous reporting period that were not included in the prior GPR (i.e., noted as “ongoing” on a prior report due to continuing program activities), please include these data in the current GPR. Provide a note of explanation in the Grantee Narrative text box clearly explaining which data correspond to which program year. For example, if you are reporting “Number of episodic volunteers generated by AmeriCorps members” with data from two program years, your explanation would read as follows: *The 500 total episodic volunteers includes 240 volunteers from the previous program year and 260 volunteers from the current program year due to ongoing activities from the previous program year that were completed after the last end-of-year GPR submission.*

The Performance Indicators Tab shows enrollment, retention, 30-day enrollment and 30-day exit rates for the 2017-2018 program year to date. ***These data are pulled from the portal the first time the tab is opened. The data do not refresh when the tab is re-opened. As a result, please do not open this tab until you are ready to complete it.*** Use the horizontal scroll bar at the bottom of the page to see the chart in its entirety.

Enrollment and Retention

For enrollment and retention, a “yes” or “no” appears in the “Meets CNCS Expectations” column. CNCS expects grantees to provide an explanation for retention rates below 85% and to achieve the highest retention rate possible. For enrollment, any rate below 100% is assessed as not meeting CNCS expectations.

For national/tribal grantees and competitive subgrantees with enrollment rates less than 100% and/or retention rates less than 85%: in the “Explanation” column to the right of the “Meets CNCS Expectations” column, explain why and identify corrective actions that are being planned to improve recruitment and retention practices, or any planned reduction in slots requested. Click on the button that says, “Enter Explanation,” type your explanation and corrective action plan, and click the “Close” button. The progress report cannot be submitted unless all required explanations have been provided. *(Please note: there is a 1,000-character limit on each explanation; any text entered above the character limit will not be saved.)*

For formula subgrantees, an explanation is not required for each subgrantee; however, the commission must use the “Grantee Narrative” section on this tab to describe its efforts to improve enrollment and retention rates in its portfolio. *(Please note: there is a 2,000-character limit on the Grantee Narrative text box; any text entered above the character limit will not be saved.)*

30-Day Enrollment and Exit

For 30-day enrollment and exit rates, a “yes” or “no” appears in the “Compliant” column. Any rate below 100% is not compliant.

For national/tribal grantees or state subgrantees with 30-day rates below 100% **for reasons entirely beyond the grantee or subgrantee’s control**, provide an explanation in the “Grantee Narrative” section. Based on this explanation, your Program Officer may change the compliance status to “Yes.” (Please note: there is a 1,000-character limit on each explanation; any text entered above the character limit will not be saved.) No other explanations are required.

Performance Measures Tab


National/Tribal GPR and Competitive GPR

Each performance measure panel contains a chart showing each output and outcome for the performance measure, as well as the MSYs and members allocated to the measure. Grantees will report on output and outcome data only; MSY and member data are not required. Please enter zeroes in the "Actual" boxes for MSYs and members on this tab. Failure to do so will result in the GPR being returned for correction. Use the horizontal scroll bar at the bottom of the page to see the chart in its entirety.

For each output and outcome, enter a numerical value documenting progress toward the target. Round any decimals to the nearest whole number. When you have entered all data for one performance measure, check the “Done with Section” box (circled on the screenshot above). This action will cause a green checkmark to appear on the accordion panel when it is collapsed, signaling that you are done entering data in this panel. If you leave any fields blank or include any characters other than numbers (commas, decimals, percent symbols, etc.) these fields will default to values of zero when you move to the next tab or save the report.

Once data have been entered for each performance measure, click the “Calculate” button at the bottom of the page. This action will enable eGrants to calculate the numerical difference between each performance measure target and actual, as well as the percent of the target that was reached. In each performance measure panel, these values will appear in the “Diff” and “% of Target” columns. A “yes” or “no” will appear in the “Met Target” column.



An explanation is required for any output or outcome measure for which one or more of the following is true:

- The actual is lower than the target value;*
- The actual greatly exceeds the target value (i.e., by 400% or more);
- Program activities and/or data collection are still ongoing for this measure, even if targets have already been met; and/or
- Data from the previous grant year that were not reported on the previous end-of-year GPR have been included in the reported actual

The content of the explanations should be as follows:

Situation	Required Explanation
Actual that is lower than the target value*	Reason(s) why the target was not met. <i>If activities are still ongoing, please see below for the required explanation content.</i>
Actual that exceeds the target value by 400% or more	Reason(s) why the actual value is significantly higher than originally projected. <i>It must be clear in the explanation that no data were double-counted and that all data are directly attributable to program activities.</i>
Ongoing program activities and/or data collection, even if the target is already met	State that activities are still ongoing and explain when program activities will be completed and a full set of data will be available. <i>Any output or outcome data that are not reported in this GPR will need to be included in next year’s end-of-year GPR</i>
Data included that were not reported in the previous grant year	Indicate what numerical portion of the actual value corresponds to the current grant year vs. the previous grant year. <i>Only data that were NOT already reported on the previous year’s end-of-year GPR should be included here. Data that were reported on the current year’s mid-year GPR SHOULD be reported again here.</i>

**If you include performance measurement data from the previous year that were not reported in the prior end-of-year GPR (i.e., noted as “ongoing” on prior report due to continuing program activities and/or data collection), it may appear that targets for the current year were met when they actually were not. Explanations should be provided for any output or outcome where the actual value for the CURRENT grant year is lower than the target value.

To enter an explanation, click on the “Enter Explanation” button in the “Explanation/Corrective Action” column. Clicking this button opens a text box where the explanation should be entered. *(Please note: there is a 1,000-character limit on each explanation; any text entered above the character limit will not be saved. Also, because of eGrants configuration issues, the system may require you to enter text in the “Explanation/Corrective Action” field for unmet measures even if an explanation is not required by these instructions. In this situation, please enter “N/A” into the “Explanation/Corrective Action” field.)*

If the explanation entered for one output or outcome target applies to other targets for the measure (e.g., an output and outcome were unmet for the same reason), clicking the “Copy” button will automatically copy the explanation to the other outputs and outcomes in the measure. If you wish to provide a different explanation for other outputs or outcomes in the measure, enter those explanations by clicking on the “Enter Explanation” button for those outputs or outcomes.

Performance measurement data reported in this GPR should not be duplicated in any other CNCS GPR submitted by your organization, including but not limited to other AmeriCorps State and National grant, Commission Support Grant, Commission Investment Fund, Volunteer Generation Fund, VISTA, or Senior Corps progress reports. (Exception: data reported in the mid-year GPR SHOULD be reported again in the end-of-year GPR.)

Formula GPR

Follow the instructions above with the following exceptions:

- Actuals are not required for applicant-determined performance measures. No fields will be available to enter these numbers (see screenshot below). An applicant-determined measure is any performance measure that does not contain a national performance measure output or outcome. Performance measures that contain a national performance measure output and an applicant-determined outcome are considered national performance measures, and actuals are required for these measures.

Enter numerical values and explanations as directed in the GPR Instructions.

- In lieu of providing actuals for applicant-determined measures, the commission must select either "Yes" or "No" in the "Met Target" column (see screenshot below). Select "No" in any situation where the subgrantee's actual for the CURRENT grant year is less than the target, even if activities are still ongoing, and even if the subgrantee also provided prior-year data.

Provide these explanation in the "Grantee Narrative" text box, clearly indicating which explanation corresponds to which subgrantee. If you run out of space, additional text may be

entered in the “Other Explanations” field on the Narratives tab. *(Please note: there is a 2,000-character limit on the Grantee Narrative text box; any text entered above the character limit will not be saved. The Other Explanations narrative field has a 32,000-character limit.)*

The progress report cannot be submitted unless all required data has been entered.

Data Quality (Required)

National/Tribal Grantees: Describe the process you used to verify data from sites reported in this GPR.

State Commissions: Describe the process you used to verify the subgrantee data reported in this GPR.

Performance Management (Required)

National/Tribal Grantees: Describe how the data you have collected about your processes or outcomes (including performance measurement and evaluation data) will be used to improve your program. What have you learned from your data collection efforts, e.g., what is working well, and what changes will your program make to improve processes and/or outcomes to better address identified community needs in the coming year?

State Commissions: Describe how you support subgrantees to use data they have collected about their processes or outcomes (including performance measurement and evaluation data) to improve their

programs. Provide examples of how subgrantees are using data to make improvements to processes and/or outcomes to better address their identified community needs in the coming year.

TTA and Monitoring (Required)

National/Tribal Grantees and State Commissions: Describe the training and technical assistance you have provided to subgrantees or sites during the reporting period.

National/Tribal Grantees: Explain how you have implemented your monitoring plan. Discuss any significant issues or trends you have identified through programmatic and fiscal monitoring and how you are responding to them. (Commissions provide this information in the Commission Support Grant GPR.)

Other Explanations (Optional)

If required narrative explanations in other sections of the GPR exceeded character limits, provide overflow explanations here.

Note: Narrative fields labeled "School Turnaround" should only be completed by School Turnaround grantees on the School Turnaround AmeriCorps GPR. All other programs must enter N/A in these fields. Please refer to the School Turnaround AmeriCorps GPR Instructions for further guidance.

*Guidance for state commissions on how to complete the Narratives tab:

- Commissions should enter narrative responses in the formula cost reimbursement GPR only; enter "See Formula Report" for the narratives on the other commission prime GPRs. The only exception is School Turnaround AmeriCorps: commissions should enter narratives specific to School Turnaround AmeriCorps subgrantees in the School Turnaround GPR.
- Commissions should not provide information from every subgrantee when responding to narrative questions. Rather, they should provide high-level analysis of their portfolio supplemented by relevant examples.

Summary Tab

This tab provides a summary of the data entered in previous tabs. Pie charts and an MSY/Member summary chart show resource allocations and member activities. For national/tribal grantees, to print a visual summary similar to the summary screen, click, "Print Grantee Report."
